
Dear Friends of Allen West Festival,

The Allentown Association is pleased to invite you to apply to be an artist vendor for the 2024 Allen West Art Festival. This year's festival will be held June 8-9. In spite of street construction, last year was a great success with more than 130 vendors, and most importantly, tens of thousands of happy attendees. This year street construction is 100% complete, and we will have our first festival without construction or COVID issues since 2019!

For the 2024 season we are back to our original footprint and with the new street design. Please read this entire section as there are changes form past years.

- 1) This year we will go back to our traditional footprint, on Allen Street and Wadsworth Street west of Elmwood Avenue.
- 2) The entire footprint will have the new street design just like last year. The new street looks amazing and our vendors were almost universally excited about the design but it is important that you are made aware of how the design can affect your booth. The new streetscape includes 8-foot-wide raised parking areas. This means the front legs of 10-foot tents will overhang the parking area by about 2 feet into the street. In order to accommodate the height difference we offer these suggestions: vendors bring a support to raise the front legs of the tents, so the tents do not slant downward. A couple of 2-inch-thick pavers to use as blocking for each leg appears to work well. Many tents also have height adjustments for their legs, making it possible to have the front legs set at a greater height than the back legs. Weighing down all tent legs is highly recommended, so they do not shift and slip from the blocking or designated area. See images below. Please also anticipate the new design with equipment and furniture inside the tent. If possible, we suggest you visit the street ahead of time, and so that you can anticipate any blocking or shims needed to make your setup work. The Allen West Festival will not be able to provide blocking or shims.

2024 Artist Application

The 24rd Annual Allen West Festival is produced and presented by the Allentown Association. We are a not for profit 501(c)(3) community association focused on historic preservation, business development and beautification of our unique Allentown neighborhood. The mission of the Allen West Festival is to showcase local artisans and craftspeople in an affordable and highprofile venue, highlight Allentown businesses, and promote the Allentown neighborhood.

GENERAL FESTIVAL INFORMATION

Vendors will be allotted one booth space that is 10' wide x 10' deep for both days of the festival. No vendor will be granted an area larger than 10'x 10' (unless additional spaces are requested, paid for and available).

All booth spaces are <u>\$315</u>. This

includes a \$35 City Permit fee, and a <u>nonrefundable</u> \$30 application fee.

No fees will be returned because of inclement weather or other unforeseen events.

The Allen West Committee will review applications and select vendors to ensure a wide variety of arts, crafts, and food offerings with an emphasis on local artisans and craftspeople.

Acceptance is not guaranteed. All vendors must have the permission of the Allentown Association to exhibit in the festival area for these days. The City of Buffalo will NOT grant a permit to any person seeking exhibit space without the Association's consent.

The festival will be located on Allen Street and Wadsworth Street west of Elmwood Avenue in our traditional footprint.

The sale of unapproved items may be cause for removal from festival area without a refund.

GUIDELINES

The festival runs from 10 AM to 6 PM on June 8th and 10 AM to 5 PM on June 9th. Exhibitors must agree to be present on both days for the full hours of the festival.

Set up can begin at 6 AM and **must be started by 8 AM.** Vehicles must be removed from the street by 9 AM. If **you arrive late you may not be granted access to your space.**

Booths must be closed for business at designated times and be removed from the street by 7 PM on both nights as the street must be reopened for traffic.

Parking is severely limited. The City owned lots on Allen St. may not available for public and vendor parking. Parking is enforced by the City and **we are not responsible for parking tickets.** The street will be closed to traffic from 6 AM to 9 PM on festival days.

Please be reminded that regulations require you to:

- display your vendor permit (after receipt from Allentown Association on the day of the event)
- display the Flame Resistant Certification typically sewn into the corner of your tent; and
- have a 10-B:C fire extinguisher.

All exhibitors who sell at shows in New York State are required to collect New York State sales tax. A "Certificate of Authority" may be obtained by calling the NYS Dept of Taxation and Finance at 1-518-485-2889.

Please be sure all materials are removed, and trash is placed in receptacles.

IMPORTANT DATES

All applications and fees must be sent to the Allentown Association and be postmarked **NO LATER THAN March 31, 2024** in order to be considered for this year's festival.

* Applications postmarked **after March 31 may** be considered, however **all** booth spaces after this date will be subject to a \$60 late fee. Notification and terms of acceptance will be sent by the end of April. If you are not chosen for this year's festival your fees will be returned less the \$30 application fee.

No refunds will be issued for: cancellations after May 1, no-shows to the festival, unable to attend, unable to set-up if late .

Fees will be returned if not selected, less the \$30 <u>non-refundable</u> application fee.
